PURPOSE

This bulletin transmits the Fiscal Year (FY) 2001-02 addendum to *ADP Allocation Methodology: Current and Historical Practices, March 1997*.

DISCUSSION

The addendum includes the allocation methodologies for funds allocated to counties in FY 2001-02, as well as a glossary of acronyms and terms.

This addendum includes additional information to provide a more thorough picture of the allocation methodology. The additional information includes: the population data used to compute the Standard Allocation Methodology (Exhibit 2); the data used for the five HIV indicators (Exhibit 3); and the data used to compute the Substance Abuse Treatment and Testing Accountability Act Allocation (Exhibit 4).
